Dear Director:

The Huntington North High School Varsity Singers are proud to announce the 16th Midwest Showcase. The contest will take place on **February 25, 2012** in the comfortable Huntington North High School 1000 seat, climate-controlled auditorium.

The invitational will feature outstanding mixed and women's show choirs and concert choirs. All choirs will perform in the auditorium during the daytime competition. In the evening, the top three women's show choirs will compete in a finals competition, as well as the five top-scoring mixed show choirs. The grand champion male and female soloists will perform in the auditorium in the evening.

Group placement is determined by the date each group registers. The sooner your group registers, the better placement you will secure. You will also receive a \$50.00 discount for each registered group when registering by June 30, 2011.

The format will feature four rows of standard Versalite platform risers set at 8", 16", 24", and 32." Upon request, the 32" back row may be subtracted for your performance and you may choose to add to the set. Otherwise, the rest of the set cannot be moved or altered.

In addition, each director will have the opportunity to submit the name of one judge they would prefer not to adjudicate their group. The option will not be available after August 31, since judges for the competition will need to be secured at that time. All names will be kept strictly confidential.

The entrance fee per group is \$250.00, but we offer a special early bird registration of \$200.00 through June 30, 2011. Soloists require a separate registration of \$25.00 each.
