Dear Director:

The Huntington North High School Varsity Singers are proud to announce their 16th annual Midwest Showcase. The contest will take place on **March 6, 2010**, in our comfortable 1000 seat, climate-controlled auditorium.

The invitational will feature outstanding mixed and women's show choirs and concert choirs. All choirs will perform in the auditorium in the daytime competition. In the evening, the top three women's show choirs will perform in a finals competition, as well as the six top-scoring mixed show choirs. Soloists will compete in the library during the day and the top male and female soloist will perform in the auditorium in the evening. Returning after its maiden voyage last year will be our "Java the Hut" talent coffeehouse.

Due to space limitations, the earlier your group registers, the easier it is to ensure your place in the schedule. We have frequently reserved all performance times before our deadline, forcing us to turn away several groups. The sooner you are able to register, the better placement you will secure. You will also receive a discount for your group when registering by July 31, 2009. Soloists will compete in the library.

Our format will feature four rows of standard Versalite platform risers set at 8", 16", 24", and 32". Upon request, the 32" back row may be subtracted for your performance, and you may choose to add to the set. Otherwise, the rest of the set cannot be moved or altered.

New to our competition this year, each director will have the opportunity to send the name of one judge they would prefer not to have judge their group. This option will not be available after August 31, since judges will need to be lined up after that date. All names will be kept strictly confidential.

The entrance fee per group is \$275.00, but we offer an early bird special registration of \$225.00 through July 31, 2009. Soloists require a separate registration of \$25.00 each.

We look forward to sharing this upcoming event with you.
